

Locating translation and interpretation services vendors for State of Utah agencies


The [Division of Purchasing and General Services](#) offers Statewide best-value cooperative contracts. These are available for use by any political subdivision and non-profit organizations.

You can find a list of current interpretation and translation services contracts by doing a keyword search on the Division of Purchasing website State Contract Search.

Search results may vary depending on the “keyword” used. Be sure to determine which type of language service you need:

- Translation: Converting written text from one language into written text into another language.
- Interpretation: The process of orally or physically rendering a spoken or signed communication from one language into another language.

Enter the keyword in the designated search area on the Division of Purchasing website (illustrated below).
